Dear Mr. Hubbard:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 01/30/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

During the inspection, I observed two classrooms. There was a total of 25 children and 4 child care staff members. While onsite, I observed programming, nap time, and free play. Each classroom had a sufficient amount of developmentally age-appropriate toys and equipment accessible to the children in the classrooms. All of the child care staff members were observed being nurturing toward the children. The center uses the MTS and AI's Pals curriculum to support early education in the classrooms.

As a result of the inspection, I did not find any rule or law violations.

Technical Assistance and Consultation were provided on the following:

- I provided guidance on the Child Care Background Check (CCBC) website.
- I provided guidance on supervised volunteer paperwork requirements.
- Please disconnect the two ISD staff from the CCBC since they are supervised volunteers and not staff members. Please disconnect Allyson Hubbell from the CCBC.

- R 400.8143(3)- Technical Assistance:** For children under school-age, at the time of a child's initial attendance, a center shall obtain, keep on file, and make accessible in the center 1 of the following: (a) A certificate of immunization showing a minimum of 1 dose of each immunizing agent specified by the department of health and human services (DHHS). (b) A copy of a waiver addressed to DHHS and signed by the parent stating immunizations are not being administered due to religious, medical, or other reasons.


