II. Purpose of Addendum

On 01/25/2023, the licensee designee, Ms. Susan Mulvey, submitted a request to add additional classroom space for while the building is undergoing construction.

III. Methodology

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 06/29/2005, 09/06/2007, 11/06/2015, 01/10/2019, 02/23/2022, and 02/13/2023.

PREVIOUSLY APPROVED SPACE:

Room 106 measures 27.33 ft. x 24.08 ft. for a total area of 658.1 square feet. Based on the required 35 square feet per preschooler or school-aged child, this space will accommodate up to 18 preschool and school-aged children.

Room 107 measures 29.4 ft. x 47 ft., for a total area of 1381.8 square feet. The maximum capacity for this space is 39 preschool and school-aged children.

Room 501 and 503 are combined into one classroom. Room 501 measures 23.67 ft. x 27.67 ft. for a total area of 654.95 square feet and Room 503 measures 28.5 ft. x 23.58 ft. for a total area of 672.03 square feet, for a total of 1326.98 square feet. This combined space will accommodate up to 38 preschool and school-aged children.

Room 502 measures 36.16 ft. x 26.16 ft. for a total area of 945.95 square feet This space will accommodate up to 27 preschool and school-aged children.

Room 505 measures 38.75 ft. x 28.67 ft. for a total area of 1110.96 square feet. This space will accommodate up to 32 preschool and school-aged children.

Room 506 measures 47.3 ft. x 28.67 ft. for a total area of 1356.1 square feet. This space will accommodate up to 39 preschool and school-aged children.

The **LHLC B/A room** is currently approved as child use space. It measures 83 ft. x 39 ft., for a total area of 3237 square feet. Deductions from the child use space include a 33.9 ft. x 12 ft. (406.8 square feet) desk/storage area and a 24 ft. x 25 ft. (600 square feet) play area for a different, unlicensed program. The total child use space of this room is 2230.2 square feet. Based on the required 35 square feet per preschooler or school-aged child, the maximum capacity for this space is 64 children. **When construction begins on the building in Spring 2023, this space will no longer be available for child care use.**

The **Viking Athletic Center** is connected to the White Lake Community Education building. This complex is comprised of various meeting and workout rooms, a school store, snack bar, basketball courts, a turf field, and an elevated walking track. The basketball courts and turf field only are approved as additional child use space. This space has not been used to determine the center's capacity.

The gymnasium is located within the White Lake Community Education Building, separate from the preschool wing. This gym is approved as additional child use space and has not been used to determine the center's capacity.

NEWLY APPROVED SPACE:

Room 102 is comprised of a large classroom with two smaller adjoining rooms to the side. The main space measures 22 ft. x 46 ft. for a total area of 1,012 square feet. Based on the required 35 square feet per preschooler or school-aged child, this space will accommodate up to 29 preschool and school-aged children.

Rooms A and B are well-defined spaces adjacent to Room 102. They each measure 17 ft. x 12 ft., for a total area of 204 square feet per space. These spaces will accommodate up to six children each.

Ms. Mulvey has requested the capacity be capped at 140 children.

There are enough toilets and sinks in the child care facility to accommodate this capacity.

The classrooms are furnished with a variety of developmentally appropriate equipment. There is an adequate amount of equipment to support the capacity.

No inspections are required for this modification.

Terms

The center's maximum capacity is 140 children ages 2.5 years and older.

The center provides preschool programs and school-aged programming.

Food service is catered from a Whitehall District Schools licensed kitchen. Therefore, food service is not considered a part of this program. This program also does not provide transportation or swimming.

V. Recommendation

I recommend the addition of Room 102 and the adjoining well-defined spaces A and B as approved child use space.
