II. Purpose of Addendum

Ms. Grissom requested the current child care space be divided into, two well defined spaces with an increase in capacity to 24.

III. Methodology

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 2/7/22.

The child care is currently using room 132. Ms. Grissom has added a well defined space to allow for two separate groups to be cared for in this space.

The east side of the classroom measures 36.25 ft. x 11 ft. for a total of 398.75 square feet of child use space. This will allow for **eight infants/toddlers**.


The west side of the classroom measures 36 ft. x 17 ft. for a total of 612 square feet of child use space. This will accommodate **16** preschool age children.

The back of the classroom that measures 22.3 ft. x 36.25 ft. will be used by both groups for bathroom and diaper changing.

The gym is also approved child use space but will not be used in capacity. The gym measures 37.58 ft. x 60 ft.

V. Recommendation

I recommend the change of space to two well defined spaces and an increase in capacity to 24 child care children.
