Dear Ms. Hall:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 01/13/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

R 400.8143 Children's records.

(1) At the time of a child's initial attendance, a center shall obtain a child information card, using a form provided by the department or a comparable substitute, that is completed and signed by the child's parent. The center shall keep it on file and accessible in the center.

Ten Child information cards were reviewed and six were missing one or more of the following: other release person, emergency medical permission, parent work information, special needs, special instructions, and allergies.

R 400.8173 Equipment.

(4) Play equipment, materials, and furniture, must be all of the following:
(b) Safe, clean, and in good repair.

The activity table lid is rough and frayed in Toddler 1.

R 400.8176 Sleeping equipment.

(18) All occupied cribs, porta-cribs, cots, and mats must be placed in such a manner that there is a free and direct means of egress and must be spaced as follows:

(b) Cots and mats must be at least 18 inches apart.

The occupied cots were not placed 18 inches apart in classroom 4.

R 400.8380 Maintenance of premises.

(4) Floors, interior walls, and ceilings must be kept in sound condition, good repair, and maintained in a clean condition.

The wallpaper is not secure to the wall in classroom 2.

On 01/13/2022, you gave us an acceptable written corrective action plan.
