Violation cited	Noncompliance observed	Plan to correct	Date to be completed
R 400.8380 Maintenance of premises	The premises was not maintained in a safe condition that did not pose a threat to safety. Bathroom doors with self-closing features did not fully close. Often, they remained open approximately six inches to two feet.	Physical Plant Services was contacted. The door was analyzed, and it was determined the pinch cards were preventing the door from closing properly. The manufacturer of the door came and adjusted the hydraulic closer. The doors are now completely closing.	1/21/22

	In Child A's classroom, previous staff members had modified the bathroom door by adding an adhesive interior handle which gave children who wanted the bathroom door shut for privacy the ability to pull it shut. Adding this handle would allow children to pull shut the heavy door more quickly than its slow-closing feature was designed to do. Staff reported that children in other classrooms where there were no handles on the interior side of the bathroom door would grab the edge of the bathroom door to pull it shut, sometimes pinching their fingers in the process		
R 400.8113(1) Program director qualifications; responsibilities	Ms. McGregor was identified as the program director. The designee had not submitted a Child Care Licensing Information Request and credentials for review and approval.	Paperwork was completed and transcripts provided to the licensing consultant. Ann McGregor has been approved and is now the Program Director assigned to Bloomin' Kids and Tots at Lone Pine.	1/19/22
