## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the on-site inspection, I observed children in care engaged in a variety of developmentally appropriate activities, including free play with Legos, drawing, dramatic play, board games, puzzles, and outdoor play. I observed large group time which included singing and story time. I also observed toileting, handwashing,

children eating lunch, and naptime. The child care staff members' interactions with the children were positive and nurturing. They were engaged with the children while being attentive to their needs.

The facility is in compliance with all applicable rules and statutes.

**Technical Assistance and Consultation were provided for the following:**

- R 400.8110 (3) (b) Applicant; licensee; licensee designee; requirements. We discussed that the current licensing rule book must be in a place, accessible, and visible to parents.
- R 400.8110 (4) Applicant; licensee; licensee designee; requirements. We discussed that all licensing inspections and special investigation reports and related corrective action plans for the last 5 calendar years must be maintained in the licensing notebook.
- R 400.8112 (2) (b) Comprehensive background check; fingerprinting. We discussed that all of the pages of the Consent and Disclosure form must be maintained in the child care staff member's file.
- R 400.8112 (2) (e) Comprehensive background check; fingerprinting. We discussed the connection and disconnection for the Child Care Background Check system.
- R 400.8131 (11) Professional development requirements. We discussed the documentation required to verify completion of training.
- R 400.8143 (1) Children's records. We discussed the admission dates listed on the child information cards and the child information cards being completely filled out.

**IV. RECOMMENDATION**

I recommend issuance of a regular license to this child care center.
