Dear Ms. Schlager:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 03/10/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

During the on-site inspection, I observed children in care engaged in a variety of developmentally appropriate activities, including outdoor play and free play with cars, dolls, and play-doh. I observed small group time which included fine motor skills activities. I also observed toileting, handwashing and children eating lunch. The child care staff members' interactions with the children were positive and nurturing.

The violations that were found are:

R 400.8152

Medication; administrative procedures.

(4) Prescription medication must have the pharmacy label indicating the physician's name, child's first and last name, instructions, name and strength of the medication, and must be given according to those instructions.

One child's epinephrine did not have the pharmacy label on it indicating the physician's name, child's first and last name, instructions, name, and strength of the medication.

R 400.8152

Medication; administrative procedures.

(5) A child care staff member shall keep all medication out of the reach of children and shall return it to the child's parent or destroy it when the parent determines it is no longer needed or it has expired.

One child's Auvi-Q expired on 02/05/2022.

On 03/10/2022, you gave us an acceptable written corrective action plan.
