III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During the on-site inspection, I observed children in care engaged in a variety of developmentally appropriate activities, including outdoor play. I also observed handwashing. The child care staff members’ interactions with the children were positive and nurturing. They were attentive to the children’s needs.

The facility is in compliance with all applicable rules and statutes.

Technical Assistance and Consultation were provided for the following:
