Findings of the Inspection

Purpose of Addendum: On 11/28/2023, licensee designee, Sarah Leece, submitted a modification request form to change the age ranges in the following classrooms:

- Infant A from birth to 6 months to birth to 12 months
- Infant B from birth to 30 months to 6 months to 18 months
- Toddlers from 12 months to 24 months to 15 months to 24 months

Findings and Conclusions: The terms of the original license have been modified on 04/06/2007, 04/13/2010, 08/27/2020, 11/28/2022, 11/26/2023, and 12/01/2023.

- On 04/06/2007, licensee designee, Mollie Blixt, requested to add summer camp/school age programs and change the age range to include children up to age 12 years old.
- On 03/09/2010, licensee designee, Ms. Blixt, requested to increase the center's capacity to 192 and approve the Make Believe Boulevard for continuous use.
- On 07/29/2020, licensee designee, Ms. Blixt, requested to increase the center's capacity from 192 to 201 and change the Twaddler room to the Kindergarten room.
- On 11/17/2022, licensee designee, Sarah Leece, submitted a request for modification to change the age range in classrooms:

- Infant B from 6 to 12 months to birth to 30 months
- Twaddlers from 24 to 30 months to birth to 30 months
- Toddlers from 12 to 24 months to birth to 30 months
- On 09/06/2023, licensee designee, Sarah Leece, requested to change the age range from 30 months to 36 months to 24 months to 36 months in the Prepper classroom.
- On 11/28/2023, licensee designee, Sarah Leece, submitted a request for modification to change the age range in classrooms:
 - Infant A from birth to 6 months to birth to 12 months
 - Infant B from birth to 30 months to 6 months to 18 months
 - Toddlers from 12 months to 24 months to 15 months to 24 months
