Dear Ms. Sarasin and Ms. Shaw:

This letter is a follow-up to the Department’s findings regarding the interim inspection conducted at your center on 05/16/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

During the onsite inspection, I reviewed children’s records and child care staff member’s records. I observed the children in care engaged in a variety of developmentally appropriate activities, including outdoor play, handwashing and toileting. I also watched the children eating lunch and observed nap time. The child care staff members all displayed positive and nurturing interactions with the children in care.

The violations that were found are:

Child care staff member, K.S., hired 2/1/2000, had not completed refresher health and safety course for year 2021 and also refresher health and safety course year 2022, within six months of when the notice was published on MiRegistry. The private links were emailed to child care staff member, K.S. on 5/24/2023 stating also in the email that the courses were to be completed by 6/7/2023.

On 5/16/2023, you gave us an acceptable written corrective action plan.
