Dear Tina Caverly:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 05/03/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

R 400.8182 Ratio and group size requirements.

(3) In each room or well-defined space, the maximum group size and ratio of child care staff members to children, including children related to a staff member or the licensee, must be as shown in Table 4:

a) Infants and toddlers, ages birth until 30 months of age shall be in a Child Care Staff Member to Child Ratio of 1 to 4 with a maximum group size of 12.

Each room did not meet Child Care Staff Member to Child Ratios of 1 to 4. The infant room had 1 child care staff member to 5 children.

R 400.8545 Fire extinguishers.

(3) Fire extinguishers shall be properly mounted, inspected, and maintained in accordance with NFPA-10. The fire extinguisher shall bear a tag indicating the last date of inspection or service

and the initials of the person who performed the inspection or service.

Fire extinguishers shall be inspected and maintained in accordance with NFPA-10. Fire extinguishers were not inspected annually. The fire extinguisher was last inspected in November 2020.

On 05/03/2022, you gave us an acceptable written corrective action plan.


