The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the on-site inspection, I observed children in care engaged in a variety of developmentally appropriate activities, including free play with Legos and MagnaTiles, and reading. I also observed handwashing and snack. The caregivers' interaction with the children was positive and nurturing. They were attentive to the children's needs.

As a result of the renewal inspection on 05/30/2024, licensing consultant, Alicia Wiggins, did not find any rule or law violations. A regular license will be issued.
