Ms. Keyser submitted a modification request to reduce the age range for L-11 from 3-year-olds to 2 years 9 months.

IV. Description of Findings and Conclusions

The following rooms are approved for child care use:

C-12 classroom measures 29 ft. X 29 ft. for a total of 841 square feet. This is sufficient space for 24 children ages 3 to 5 years.

C-16 classroom measures 29 ft. X 29 ft. for a total of 841 square feet. This is sufficient space for 24 children ages 3 to 5 years.

W-1 classroom measures 26 ft. X 28 ft. for a total of 728 square feet. This is sufficient space for 21 children ages 3 to 5 years.

W-2 classroom measures 26 ft. X 28 ft. for a total of 728 square feet. This is sufficient space for 21 children ages 3 to 5 years.

W-3 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-4 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-5 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-6 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-7 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-8 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-9 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-10 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-11 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

W-12 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

L-1 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

L-2 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

L-5 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

L-6 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

L-7 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

L-8 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

L-11 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 2.9 to 5 years.

L-12 classroom measures 28 ft. X 28 ft. for a total of 784 square feet. This is sufficient space for 22 children ages 3 to 5 years.

The center has 32 toilets and 93 sinks. Based on the number of toilets the maximum capacity for the center is 480 children.

The following classroom is approved but not included in the center's capacity: Gross motor classroom measures 50 ft. X 37 ft., plus 31 ft. X 17 ft. for a total of 2,377 square feet. This allows for a capacity of 68 children ages 3 to 5 years.

Each classroom is adequately equipped with enough age-appropriate equipment for the capacity. This includes books, dramatic play items, art and crafts materials, games, music materials, large and small motor, and sensory exploration materials.

An environmental health inspection was completed on 12/08/2021 and fire safety inspection was completed on 08/16/2019. A lead risk hazard assessment is not required because the building was constructed after 1978.

V. Recommendation

I recommend lowering the age range for classroom L-11 from 3 years of age to 2 years 9 months.
