## IV. Description of Findings and Conclusions

The following rooms are approved for use:

The Faith classroom #114 measures 39 ft. X 30 ft. for a total of 1,170 square feet. The classroom is approved for 33 children ages 2.5 years to 5 years based on the amount of equipment in the classroom.

The Love classroom #112 measures 30 ft. X 22.8 ft. for a total of 684 square feet. This is sufficient space for 14 children ages 2 years to 2.5 years.

### **The following classroom is not approved for child care use:**

An onsite inspection is required before the following classroom can be used for child care children.

The Hope classroom #115 measures 31.5 ft. X 25 ft. for a total of 788 square feet. This is sufficient space for 23 children ages 2.5 years to 5 years.

This equals a total of 40 children, 2- 5-year-olds.

The center has 1 toilet and 1 sink in the Faith classroom and 1 toilet and 1 sink in the Love classroom which is enough to accommodate the center's capacity of 40 children.

The center is adequately equipped with enough age-appropriate equipment to support the capacity. This includes books, dramatic play items, science materials, puzzles, math, art, and crafts materials.

A fire safety, environmental health, or lead risk hazard were not required.

**V. Recommendation**

I recommend the addition of the Love classroom and the capacity for the center to be increased from 8 to 40 children.
