Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the onsite inspection, I observed the child care staff engaging children in a variety of activities including engaging infants with language, outdoor time, and facilitating conversation during lunch time. I provided consultation and technical assistance for the following child care licensing rules: R 400.8134(3)(b), R 400.8350(5), and R 400.8530(1).
