At the time of this onsite inspection, children were divided into two groups with one group playing in the gym, and the second group engaging in free play activities in the main classroom. I observed that one of the child care staff members actively engaged with each group of children and met the needs of individual children in a developmentally appropriate and kind manner. I observed that two of the child care staff members engaged minimally with children. I did not observe any safety concerns.

As a result of the renewal inspection on 3/7/2023, I did not find any rule or law violations. You will receive your regular license in the mail.
