III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During the inspection, the center was found to be in compliance with all applicable rules and statutes except for the following violations:

R 400.8122 Lead caregiver; qualifications; responsibilities.

(5) Lead caregivers shall meet 1 of the following qualifications shown in Table 3:

(d) Valid child development associate credential with 480 hours of experience

Two lead caregivers at the center do not have a valid child development associate (CDA) credential. They have taken the courses required but do not yet have a valid credential.

IV. RECOMMENDATION

Upon the receipt of an acceptable corrective action plan, I recommend issuance of a regular license to this child care center.
