R400.8134(3)(b)	In the toddler room, the child care staff member did not ensure that three children washed their hands after diapering.	Director has spoken to the staff about proper handwashing procedures.	09/21/2022

R400.8152(5)	In the toddler room, two medications were being stored for named children, which were expired.	Expired medications have been sent home with children's parents. Will continue to monitor.	09/21/2022
R400.8185(5)	In the infant room, the posted primary caregiving assignments were not up to date.	The primary care chart has been updated. Will check and update it every morning.	09/21/2022

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
