All of the staff members were unaware of who was in charge in the absence of the program director, Karlie Fournier.	The program director, Karlie Fournier will ensure that if she is absent from the center there is a designated child care staff member left in charge in her absence.	09/14/2023


R400.8330 (20) Food services and nutrition generally.	I observed an infant sitting on the floor leaning on a boppy pillow, with a blanket being used to prop a bottle into her mouth.	All child care staff members will refrain from bottle propping at all times.	09/14/2023
R400.8330 (21) Food services and nutrition generally.	I observed an infant not being held by the child care staff member during feeding, as required. The infant was not able to hold their own bottle as evidenced by the bottle being propped into the mouth with a blanket.	All child care staff members will hold infants during feeding; except when infants resist being held and are able to hold their own bottle.	09/14/2023

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
