

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.


During the onsite inspection, I observed tummy time in the infant room upon my arrival. I observed children engaged in free play activities, while playing with age-appropriate toys. I observed children being directly supervised while napping during rest time. I observed safe sleep practices being utilized in the infant room. I observed hand washing and snack time. I observed diapering and proper handwashing techniques being utilized for children and child care staff members. I

observed literacy activities. I observed caregivers, parents, and children during pick up time. Caregiver interactions with children were positive and nurturing. Required records were organized and readily available.

The facility is in compliance with all applicable rules and statutes.

#### IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
