Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the onsite inspection, I observed children engaged in free play activities upon my arrival. I observed children playing with blocks, puzzles, and other age appropriate toys. I observed children using imaginative play while socializing with other children. I observed table time which included arts and crafts and literacy activities. I observed handwashing after bathroom use. Caregiver interactions with children were observed to be positive and nurturing. Required records were organized and readily available for review.

As a result of the renewal inspection(s) on 2/28/2024, licensing consultant Mary Smith did not find any rule or law violations. A regular license will be issued.


