Attached is your renewal inspection report. During the onsite inspection I observed parent drop off, sign in and attendance procedures and children washing their hands and eating breakfast and lunch prepared in a licensed kitchen and delivered to the room. I observed child records to be organized, readily available and to contain necessary information. I observed circle time, calendar, group time, free play, clean up, and multiple transitions throughout the day. I observed the children ready themselves to play outside and to enjoy the hula hoops provided to them for guided free play. I observed nurturing and appropriate interactions between children and staff. I observed rest time. It is evident that this program has an established routine and that the children are thriving in this environment. Area manager, Rose Rafferty, was present for a portion of this onsite inspection.

During the renewal inspection on 12/08/2022, I found one violation listed below and explained in the attached report:

III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the inspection, the center was found to be in compliance with all applicable rules and statutes except for the following violations:

R 400.8179

Program.

(10) When media are used with children 2 years of age and older, all of the following apply:

(c) Media with violent or adult content are prohibited while children are in care.

I observed several VHS movies rated PG and PG13 on a cart with a television and a VCR being used for the Before/After the Bell Program participants. Media with violent or adult content are prohibited while children are in care.

A corrective action plan was requested and approved on 12/09/2022. It is expected that the corrective action plan be implemented within the specified time frames as outlined in the approved plan. A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
