Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During the onsite inspection, I observed children preparing for rest time upon my arrival. I observed the caregivers providing direct supervision of children napping during rest time. I observed safe sleep practices being utilized for infants. I observed older children engaged in quiet activities while others were resting. I observed hand washing and snack time. I observed diapering and proper

handwashing techniques being utilized for infants and child care staff members. I observed children engaged in free play activities. I observed the caregivers, parents, and children during pick up time. Caregiver interactions with children were observed to be positive and nurturing. Required records were organized and readily available for review.

As a result of the renewal inspection(s) on 4/2/2024, licensing consultant Mary Smith did not find any rule or law violations. A regular license will be issued.
