### Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During the onsite inspection, I observed the caregivers providing direct supervision to children napping during rest time upon my arrival. I observed children who were not resting engaged in quiet activities such as reading. I observed children transitioning from rest time to free play activities. I observed hand washing and snack time. I observed outdoor play activities. I observed large circle

time and children engaged in literacy activities. I observed the caregivers, parents, and children during pick up time. Caregiver interactions with children were observed to be positive and nurturing. Required records were organized and readily available for review.
