Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the onsite inspection, I observed the caregivers providing direct supervision to children napping during rest time upon my arrival. I observed some children engaged in quiet activities such as reading while other children were resting. I observed children transitioning from rest time to snack time which included using the bathroom and handwashing. I observed literacy activities during large circle time. I observed handwashing and snack time. I observed children engaged in arts and crafts while making Valentine's Day cards for their loved ones. I observed caregivers, parents, and children during pick up time. Caregiver interactions with children were positive and nurturing. Required records were organized and readily available for review.

As a result of the renewal inspection(s) on 2/14/2024, licensing consultant Mary Smith did not find any rule or law violations. A regular license will be issued.
