The purpose of the Interim inspection was to determine compliance with applicable licensing statutes and administrative rules for child care Center.



I observed children and caregivers during large circle time which included literacy and math activities. I observed caregivers and children during family style lunch and handwashing. I observed children preparing for rest time. Caregiver interactions were observed to be positive and nurturing. Required records were organized and readily available for review.
