### Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the onsite inspection, I observed the caregivers providing direct supervision to the children who were napping during rest time upon my arrival. I observed diapering and proper handwashing techniques being utilized for infants and by caregivers. I observed children engaged in free play activities. I observed children playing with age appropriate toys. I observed children engaged in

singing and dancing during literacy activities. I observed children engaged in arts and crafts activities. I observed handwashing and snack time. I observed the caregivers provide comfort while feeding infants. I observed the caregivers, parents, and children during pick up time. I observed the school bus dropping two children off for after school care and the caregiver outside getting them off the bus. Caregiver interactions with children were positive and nurturing. Required records were organized and readily available for review.
