On July 24th, Ms. Rodarte submitted a request to change the hours and days of operation from 7:00 a.m. – 4:00 p.m. Monday through Thursday to 7:00 a.m. – 6:00 p.m. Monday through Friday.

IV. Description of Findings and Conclusions

The terms of the original license were modified on 02/02/2023 and 07/26/2023.

This child care center is located in Trinity United Methodist Church in Chesaning, Michigan. It is located about two miles east of the intersection of M-52 and M-57.

Approved space (room numbers, sizes, capacity and ages of children for which each room/well-defined space is approved, etc.):

The child care room is located in the south wing of the church. The child care room is 36ft. x 24ft. for a total of 864 sq. ft. This room has a capacity of 24 children, 3 years of age through 12 years.

Equipment: The center has an adequate amount and variety of age-appropriate materials, furniture, books, and games for the intended use. The play equipment is age appropriate and adequate for the requested capacity of 20 children, 3 years to 12 years.

Number of sinks and toilets: The girl's bathroom is located in a nearby hallway. This is the only bathroom that will be used by the child care. It has three toilets and two hand sinks. Due to the distance between the child care room and the bathroom, direct supervision will be provided for all children using the bathroom. The child care will only accept fully potty-trained children. There is one handwashing sink in the classroom.

Outdoor play area - location, fenced or not, water hazards: There is one play area located on-site which will be used for child care. The outdoor play area is a large outdoor grassy area, which is adjacent to the south wing of the church. It is partially fenced in and there are no water hazards. There is no installed equipment on the large outdoor play area. Play equipment that can be taken outdoors is available.

Documentation if a lead hazard risk assessment was required and the results: A lead risk hazard assessment was conducted on 06/17/2021. No hazards were found.

Documentation of playground safety: A playground safety inspection is not required as there is no installed playground equipment.

B. Program Description

Ages of children served: Roots and Wings Discovery Preschool will accept children ages 3 years through 12 years.

Proposed days and hours of operation: This center will be open Monday through Friday from 7:00 a.m. – 6:00 p.m.

Full or part time (AM or PM sessions or both): Children can be enrolled part-time or full-time.

Other program components - transportation, swimming, food service: No transportation or swimming component will be provided. Parents are expected to provide lunch and snacks.

Name of program director and under what rules the program director is qualified: Ashley Rodarte has been approved as the Program Director under R 400.8113 (7) (d) and (9).

Is there a central administrator that meets the administrative requirement? There is not a central administrator.

Explanation of variance(s), if any: There are no variances.
