She has been observed by CCSM2, CCSM3, and program director, Rachelle Terrana, to grab Child A and smack his hands. She was also observed to grab Child B and smack his hand. CCSM1 has been observed to aggressively grab Child A and Child B on different occasions and drag them to different locations.</p> <p>This was the second investigation involving inappropriate discipline with CCSM1. The location of the center is the same, however it is under a different license. The first investigation also had findings of inappropriate discipline.</p>	Child Care Staff member 1 was dismissed on 03/22/2022.	Immediate
