Dear Ms. Avery:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 10/20/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

R 400.8131 Professional development requirements.

(12) When the department of licensing and regulatory affairs or the department of education publishes a notice that a new health and safety update document or a new health and safety update training activity has been published on MiRegistry, the licensee shall ensure that all personnel read and acknowledge the document or complete the activity within 6 month of the notice.

Two child care staff members who have been employed since at least 2018 did not complete the new health and safety update documents in MiRegistry within six months of the notice for 2020 and 2021. As technical assistance, the 2022 health and safety update needs to be completed by these child care staff members by October 31, 2022.

R 400.8380 Maintenance of premises.

(3) Roofs, exterior walls, doors, skylights, and windows must be weathertight and watertight and kept in sound condition and good repair.

The windows in the Pooh Bear Room, School-Age Room, and Teddy Bear Room had chipping and peeling plaster around them and were not kept in sound condition and in good repair.

R 400.8380 Maintenance of premises.

(4) Floors, interior walls, and ceilings must be kept in sound condition, good repair, and maintained in a clean condition.

The ceiling in the Pooh Bear Room had chipping plaster and was not in sound condition and good repair.

On October 20, 2022, you gave us an acceptable written corrective action plan.
