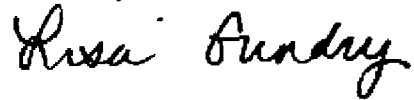

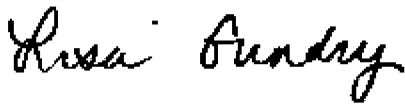
The facility is in compliance with all applicable rules and statutes.
