III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Description of Facility

Elite Early Learning Center II is a two-building preschool that will house infants to school-agers. It is located in Corunna, MI.

Approved space (room numbers, sizes, capacity and ages of children for which each room/well-defined space is approved, etc.):

The following rooms have been measured and approved:

Building 1:

- Infant Room (birth to 12 months of age) measures 22 ft. x 16 ft. & 6 ft. x 9 ft. & 10 ft. x 7 ft. & 10 ft. x 7 ft. totaling 546 sq. ft. This room can accommodate 8 children birth to 2.5 years of age. The room has a large sleeping space that will only be used when children are sleeping and will be supervised at all times.
- Wobbler Room (12 months to 2 years of age) measures 20 ft. x 11 ft. totaling 220 sq. ft. This room can accommodate 4 children birth to 2.5 years of age.
- 3-year-old Preschool Room measures 23 ft. x 16 ft. totaling 368 sq. ft. This room can accommodate 10 children 3 years to school age.
- GSRP Room (4 years of age) measures 37 ft. x 16 ft. totaling 592 sq. ft. This room can accommodate 17 children 3 years to school age.
- Library Room measures 16 ft. x 10 ft. totaling 160 sq. ft. This room can accommodate 4 children 30 months to school agers at a time. This room will not be used in the capacity.
- Junior Preschool Room (30 months to 4 years of age) measures 11 ft. x 23 ft. totaling 253 sq. ft. This room can accommodate 7 children 30 months to school age.
- Toddler Room (12 months to 24 months of age) measures 18 ft. x 14 ft. totaling 252 sq. ft. This room can accommodate 5 children birth to 30 months.

Building 2:

- School-Age Room measures 24 ft. x. 24 ft. & 14 ft. x 13 ft. totaling 758 sq. ft. This room can accommodate the approved 15 children due to only one bathroom in this building.

- Lunch Room measures 12 ft. 23 ft. totaling 276 sq. ft. This room can accommodate 8 school age children. This room will not be used in the capacity.
- Multi-Purpose Room measures 37 ft. 39 ft. totaling 1443 sq. ft. This room can accommodate 41 children 30 months to school agers. It will not be used in the capacity.

Equipment:

There is an adequate supply of developmentally appropriate toys and equipment for the children to play.

Number of sinks and toilets:

There are a total of 5 toilets, 1 urinal and 7 sinks in building 1 for the children to use. In building 2 there is 1 toilet and 1 sink. This is adequate for the total capacity of 66 children (51 in building 1 and 15 in building 2).

Outdoor play area - location, fenced or not, water hazards:

The outdoor play area is located on the back side of the building broken into two areas. The infant and toddler play area is in a fenced area that is fully grassed. This area does not have any elevated play equipment but does have age-appropriate playhouses and toys for the children. The preschool to school age play area is located on the back side of the building where it is fully grassed and has a cemented area as well. The area is not fenced and the children will always be supervised. This area also has age-appropriate toys for the children to use while outside.

Documentation if a lead hazard risk assessment was required and the results:

The buildings were built prior to 1978 so a lead hazard risk assessment was required. The buildings had no concerns of lead hazards in any areas.

Documentation of playground safety:

There is no elevated equipment on the playground, so a playground inspection was not required.

B. Program Description

Ages of children served:

The center will provide care for children ages birth to school age.

Proposed days and hours of operation:

The center will operate year-round Monday through Friday from 5:30 AM to 6:30 PM.

Full or part time (AM or PM sessions or both):

The center will be a full-time program.

Name of program director and under what rules the program director is qualified:

Kayla Morell is the program director. She has an associate's degree and qualifies under licensing rule R 400.8113(9)(c) and (13).

Is there a central administrator that meets the administrative requirement?

There is not a central administrator for this center.

Explanation of variance(s), if any:


There are no variances.

I recommend issuance of an original license to this child care center.


