

III. DESCRIPTION OF FINDINGS & CONCLUSIONS



Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

The facility is in compliance with all applicable rules and statutes.

Consultation provided: A new hot water heater was installed. It appeared all the classrooms had hot water but the toddler classroom. It took a long time to get hot. I suggested they have maintenance come and check on this.

I recommend issuance of a regular license to this child care center.
