II. Purpose of Addendum

On 08/02/2022, the licensee designee Dijani Dagle requested the adding of one classroom 109. The capacity will be decreased from 66 to 36.

IV. Description of Findings and Conclusions

The terms of the original license were modified on 09/30/2016.

The following spaces are currently approved: Portable 102A

New approved spaces:

Room 109 measures 38 ft. x 17 ft., providing a total of 646 square feet.
This accommodates the requested capacity of 18 children, ages 4 to 5 years.

There is an adequate and varied amount of age-appropriate equipment and materials available in the room.

The outdoor play area has approved play structures for PreK.

The facility has a total of 7 toilets and 7 sinks which supports the capacity.

Food service will continue to be provided by the licensed onsite kitchen.

The district is hiring staff for the new space and will forward an updated spreadsheet of all directors by the second week of the school year. It is understood no person will be on staff without proper credentials and child care fingerprints on file.

V. Recommendation

I recommend the approval of using room 108, the Gym and lowering the capacity from 66 to 36.
