R 400.8315(1)	The refrigerator temperature in the kitchen area tested at 57 degrees Fahrenheit.	I will develop a new plan to have refrigerator checked daily. I will turn temperature up in kitchen refrigerator and have it serviced if needed.	03/07/2024
R 400.8335(8)(a)	Two containers of milk was observed in the infant room without a labeling of the date it was opened.	Will discuss with staff the labeling rule requirements for milk.	03/07/2024


R 400.8188(11)	I observed a 13-month-old child sleeping on the floor on a bobby pillow.	I will retrain staff on the importance of safe sleeping equipment.	03.08.2024
R 400.8112(2)(b)	A signed consent and disclosure was not on file for CCSM, A.R.	I will maintain a signed consent and disclosure on file for all staff. Staff member A.R. completed a new form while licensing was onsite.	03.07.2024
R 400.8161(2)	Ms. Smith did not have emergency procedures for viewing during this onsite. The written emergency procedures required in this rule were not posted in a place visible to staff and parents	I will develop updated procedures to meet the requirements of this rule and post them.	03.15.2024
R 400.8161(1)	Ms. Smith did not have emergency procedures for viewing during this onsite. The written emergency procedures required in this rule were not posted in a place visible to staff and parents.	I will develop updated procedures to meet the requirements of this rule and post them.	03.15.2024
