

## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the onsite inspection I observed two classrooms. The children worked on beginning sounds, writing, math, reading readiness and reviewed money. The children were engaged in their learning. They ate macaroni and cheese, ham, mixed vegetables, and milk. Mrs. Duncan did not have an updated fire safety inspection at the time of the inspection. Technical Assistance was provided to Mrs. Duncan by me and manager, Mrs. Ellington explaining the licensing rule regarding the cycle of the fire safety inspection. The fire safety inspection is scheduled for 05/03/2023.
