

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.


During the onsite inspection, there were no children present. A thorough inspection was conducted except an observation of the program. Ms. Rodgers is partnering with Grow Detroit where they will plant flowers and grow a garden. Mrs. Rodgers showed me where the children engage in fine motor activities using rice. The children colored rice with different colors and watched it dry. They used measuring

tools to measure the correct amount of food coloring and vinegar for this activity.  
The finished product is now an ongoing fine motor activity.

The facility is in compliance with all applicable rules and statutes.
