

## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations. and a review of some of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards and immunizations.

During the onsite inspection, children were assembled in the gymnasium. They were working on homework. There are activities they can be involved in such as gross motor activities as well as fine motor activities.

During the inspection, the center was found to be in compliance with all applicable rules and statutes except for the following violations:


**R 400.8112            Comprehensive background check; fingerprinting.**

**(2) An applicant or licensee shall do all of the following:  
(e) Within the department's child care background check system, accurately complete and maintain the connection, disconnection, or withdrawn status of each individual associated with the license.**

During the onsite inspection there were former employees who were still connected in the child care background check system. Ms. Foard went in and corrected the violation by disconnecting all former employees.

#### **IV. RECOMMENDATION**

I recommend issuance of a regular license to this child care facility.
