II. Purpose of Addendum

Licensee Designee, Shekelia Stokes sent a modification request on 07/17/2022 to change her servicing age and program director. She services ages 6 weeks to 12 years old and wants to serve ages 6 weeks to 13 years. She wants to change the program director to MacRida Galloway.

III. Methodology

07/17/2022 Modification request received
07/28/2022 Inspection completed onsite

IV. Description of Findings and Conclusions

The terms of this license have been modified on 08/05/2022, 03/07/2022, 06/05/2019.

An environmental health inspection, fire safety inspection, and lead hazard risk assessment were not needed for the modification.

Children's R US is comprised of one room that is divided into two well-defined spaces to create an infant/toddler classroom and a preschool/school-aged classroom. The bookshelf that is used to divide the two well-defined spaces will be moved closer to the preschool/school-aged classroom to give the infant toddler classroom more child use space. This would decrease the preschool/school-age child use space. The following spaces are approved as child use space:

- Infant/ toddler classroom is 23ft. x 17ft. providing a total of 391 square feet. Based on 50 square feet per child, this allows for a total capacity of 8 children birth – 30 months.
- Preschool/School-age classroom was measured in two parts. The room is 24ft. x 11ft. and 12ft. 7ft., providing a total of 348 square feet. Based on 35 sq. feet per child, this allows for a total room capacity of 9 children 30 months-school-age.

The total space is sufficient for a total license capacity of 17 children birth through 12 years.

I provided Ms. Stokes technical assistance regarding R400.8182(8). If there are children of mixed ages in the same room or well-defined space, then the ratio and group size shall be determined by the age of the youngest children present.


There is a total of 3 handwashing sinks, and 2 toilets available for child use. There is 1 food prep sink in the kitchen.

The classrooms are furnished with a variety of developmentally appropriate equipment.

Terms: The total capacity of the center is 17 children ages, 6 weeks – 13 years and Ms. MacRida Galloway be the approved program director.

V. Recommendation

I approve the age range of the center be changed from 6 weeks to 12 years to 6 weeks to 13 years old and Ms. MacRida Galloway be the approved program director. She has submitted a copy of her transcripts. Official transcripts are forthcoming.
