II. Purpose of Addendum

The licensee would like to change the age range in room one to 0 to 3 and add additional child use space in room 2.

III. Methodology

07/26/2022 – Modification Request Received

08/01/2022 and 08/29/2022 – Inspection Completed On-Site

IV. Description of Findings and Conclusions

The terms of the license were modified on 08/01/2022 and 06/21/2022.

Cribs 2 College is located between Norfolk and W. Eight Mile at 20401 Livernois in the city of Detroit. The entire building will be used for child use space.

Room 1 measures 30 x 32, providing a total of 960 square feet. This accommodates a capacity of 19 children ages birth through 3 years. The licensee is aware that the ratio of 1:4 must be maintained with mixed age groups including infants and toddlers.

Room 2 space one measures 33 x 17 which will accommodate 11 children, space two measures 29 x 18 which will accommodate 10 children and space three measures 29 x 22 which will accommodate 13 children providing a total of 1721 square feet. This accommodates a capacity of 34 infants/toddlers. Due to lack of water closets this space can only accommodate a total of 32 children at one time. There is a diaper changing sink in this area.

Room 3 measures 29 x 29, providing a total of 841 square feet. This accommodates a capacity of 24 preschool children.

The overall approved space is sufficient for the capacity of 75 children ages birth through school age.

The facility has adequate and varied amounts of equipment to meet children's developmental needs. All of the equipment inspected was safe, clean and in good repair. An updated inventory list will be provided to the department.

There are five toilets and five hand washing sinks. There are additional sinks in the kitchen used for food prep. There are two additional portable sinks in the center.

This supports the center's capacity of 75 children.

Cribs 2 College will service children, birth through school age.

The facility will operate from 06:30 a.m. to 06:00 p.m., Monday through Friday.

Transportation will not be provided.

A fire, environmental and lead assessment are on file at the center.

V. Recommendation

I recommend modifying the license by changing the age range in room one to 0 to 3 and adding additional child use space in room two.
