II. Purpose of Addendum

Licensee Designee, Shekelia Stokes sent a modification request on 07/17/2022 to change her servicing age. She services ages 6 weeks to 12 years old and wants to now serve ages 6 weeks to 13 years.

III. Methodology

07/17/2022 modification request received
07/28/2022 inspection completed onsite

IV. Description of Findings and Conclusions

The terms of the original license were modified on 08/05/2022 and 10/20/2021.

An environmental health inspection, fire safety inspection, and lead hazard risk assessment were not needed for the modification.


The following rooms are approved as child use space:

- Infant/toddler classroom is 36ft. x 10ft. providing a total of 360 sq. ft. Based on 50 sq. ft. per child, this accommodates 10 infants and toddlers. This approval is based on the number of cribs provided by the center.
- The South preschool classroom was measured in two parts. The first part is 13ft. x 26 ft., and the second part is 13ft. x 9ft., together, this provides a total of 455 sq. ft. Based on 35 sq. ft. per child, this accommodates 13 children 2½ – 13 years of age.
- The Southeast preschool is 36 ft. x 15 ft., providing a total of 558 sq. ft. Based on 35 sq. ft. per child, this accommodates a total of 16 children 2 ½ years of age.

The total capacity of the center is 39 children, ages 6 weeks – 13 years of age. The center provides transportation.

V. Recommendation

I approve the age range for this child care center be 6 weeks to 13 years old.
