This letter is a follow-up to the on-site inspection conducted at your center on 09/02/2021. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

**R 400.8340 Food services and nutrition; provided by parents.**

(9) Beverages and food must be fed only to the child for whom the item is labeled.

On 01/24/2023, I received a telephone call from program director, Marilyn Paschal that an infant was misfed. A child care staff member mistakenly fed a bottle of breast milk to an infant that belonged to another infant. Both parents were notified and an incident report was submitted to the department.

Due to the violations, you must send us a corrective action plan by 02/14/2023. You can use our [corrective action plan](#) form or create your own.

If you need help writing the corrective action plan, please contact me. If you do not send a corrective action plan, you may face disciplinary action. The corrective action plan must include the following:

- How compliance with each rule will be achieved.
- Who is directly responsible for implementing the corrective action for each violation.

- Specific time frames for each violation as to when the correction will be completed or implemented.
- How continuing compliance will be maintained once compliance is achieved.
- The signature of the responsible party and a date.


Upon receipt of an acceptable corrective action plan, there will be no change to your license status.
