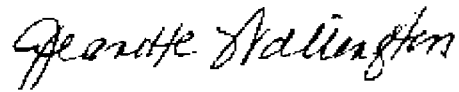

III. DESCRIPTION OF FINDINGS & CONCLUSIONS

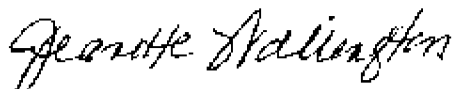
Language for Full Inspection
