They were missing the following information: physician's name, phone number, parent's employer name, work phone number, parent's signature and date of signed.	Licensee will ensure that the children files are reviewed and updated with missing information.	06/23/2022
R 400.8143 Children's records.	Three of the ten children records reviewed did not have immunizations on file at the center.	Licensee will ensure that the children files are reviewed and updated with missing information.	06/23/2022
R 400.8143 Children's records.	Two of the ten children records reviewed did not have physicals on file at the center.	Licensee will ensure that the children files are reviewed and updated with missing information.	06/23/2022
R 400.8182 Ratio and group size requirements.	On 05/18/2022, the toddler room was out of ratio. There were 14 toddlers present with two child care staff members.	Licensee will ensure that the center will be in ratio at all times. More staff will be acquired, and proper scheduling will be completed.	06/23/2022
R 400.8335 Food services and nutrition; provided by center.	In the kitchen, there was a gallon of milk that was not labeled with the date opened. In the infant room, there were two containers of Silk milk that was not labeled with the date opened.	Licensee will ensure that milk is labeled with the date that it is opened.	06/23/2022
R 400.8340 Food services and nutrition; provided by parents.	In the infant room refrigerator, there were five bottles that were not labeled with the child's first and last name and date. In the kitchen refrigerator, there was one bottle that was not labeled with the required information.	Licensee will ensure that all bottles are labeled with the child's first, last name and date.	06/23/2022

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
