R 400.8143(1) Children's records.	11 of the 12 child information cards reviewed were incomplete. They were missing the following information: parent's employer name, work phone, physician's name, physician phone, parent signature and date.	Licensee designee will ensure that all child information cards are reviewed and updated.	07/05/2023

R 400.8143(3) Children's records.	Four of the 12 children records reviewed did not have immunizations on file at the center.	Licensee designee will ensure that all child information cards are reviewed and updated.	07/05/2023
R 400.8173 Equipment.	The center allows the children to play with shaving cream. Shaving cream should not be used with the children due to the toxic warning label.	Licensee designee will ensure that the center does not use materials that are considered hazardous.	07/05/2023
R 400.8380(4) Maintenance of premises.	The ceiling at the center is not in good condition. There are seven or more ceiling tiles that has water stains.	Licensee designee will ensure that the ceiling is in good conditions.	07/05/2023
R 400.8380(7) Maintenance of premises.	The light fixtures at the center are not in good repair. There are 13 lights in the front room that does not work.	Licensee designee will ensure that light fixtures are in good repair.	07/05/2023

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
