II. Purpose of Addendum

On 03/25/2022, the licensee requested to modify her license by adding additional child use space and increase the capacity of the license.

III. Methodology

03/25/2022 – Modification Request Received

04/07/2022 – Inspection Completed On-Site

IV. Description of Findings and Conclusions

The terms of the original license were modified on 04/11/2022.

Room 112 measures 15 ft. x 18 ft., providing a total of 270 square feet. This accommodates a capacity of 8 children ages 2 ½ through 12 years.

Room 116 measures 19 ft. x 19 ft., providing a total of 361 square feet. This accommodates a capacity of 10 children ages 2 ½ through 12 years.

Room 115 measures 24 ft. x 15 ft., providing a total of 360 square feet. This accommodates a capacity of 10 children ages 2 ½ through 12 years.

Rooms 113 and 114 measures 18 ft. x 32 ft., providing a total of 576 square feet. This accommodates a capacity of 16 children ages 2 ½ through 12 years.

Room 103 measures 19 ft. x 19 ft., providing a total of 361 square feet. This accommodates a capacity of 10 children ages 2 ½ through 12 years.

Room 106 measures 15 ft. x 19 ft., providing a total of 285 square feet. This accommodates a capacity of 8 children ages 2 ½ through 12 years.

The overall approved space is sufficient for the capacity of 62 children ages 2 ½ through 12 years.

The facility has adequate and varied amounts of equipment to meet children's developmental needs. All of the equipment inspected was safe, clean and in good repair. A detailed inventory list is on file with the department.

There are two toilet rooms equipped with 7 water closets, 4 urinals and 4 hand-washing sinks. There is an additional toilet and hand-washing sink in room 103.

Little Guys and Dolls will service children, 2 ½ through 12 years.

The facility will operate from 06:00 a.m. to 06:00 p.m., Monday through Friday.

Transportation will be provided.

A fire, environmental and lead assessment are on file at the center.

V. Recommendation

I recommend modifying the license by adding additional child use space in room 112 and increasing the capacity of the license.
