Dear Ms. Thompson:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 03/28/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

During the interim inspection, I observed child playtime, handwashing, and lunch. Ms. Thompson used positive guidance and gave children choices to promote cooperation and compliance with her requests. She used well-established routines to help guide children through transitions from one activity to the next and gave them a five-minute warning before it was time to clean up so they knew what to expect.

As a result of the inspection, I did not find any rule or law violations.

I provided Technical Assistance on the following:

- Posting new emergency plans and the new recall list.
- Fixing the handrail on the front steps and sending a photo to show compliance.
- New Child In Care Statements are needed for all enrolled children and that all required information is present including children's names in Section 1.
- Ordering new/extra child safety locks to secure kitchen drawers.
- Lighters were moved from an unsecured drawer during the inspection.
- As a reminder, all required meal components must be served together to comply with CACFP rules.
- Your child care staff member will need to complete the 2023 Health and Safety Refresher within 6 months of notice.


