ALLEGATION: The licensee is providing child care at a home that is not licensed.

INVESTIGATION:

On 5/23/2024, I conducted an unannounced onsite inspection at the AirBnB that Jessica Harris was renting. I conducted an interview with Jessica Harris.

Jessica Harris stated that she no longer lives in her home that is licensed and she is moving to a new home. She will be getting licensed at her new home as soon as possible. Her family has been renting the AirBnB home for about a week and are leaving the home within the next few days. She stated that only her two children and her niece have been at the AirBnB home, and she will not have any child care children at the AirBnB home.

Jessica Harris stated that she is ready for her license to be closed as she is moving to a new home.

On 5/24/2024, I conducted an interview with the reporting source via telephone.

The reporting source stated that they saw children being dropped off on 5/17/2024 to the AirBnB home, but that no children have been witnessed being dropped off or picked up since then. The reporting source could not identify whether the children were related to Jessica Harris or how many children were dropped off to the home.



On 6/3/2024, I conducted an exit conference with Jessica Harris via telephone. We discussed the findings of the investigation and that I will not be citing any rule violations. We discussed that I will close out her current license on 6/4/2024.
