## IV. Description of Findings and Conclusions

The terms of the original license have been modified 08/18/2022 and 03/04/2020.

The facility is a single-story home without a basement located just outside the city of Cheboygan.

### **Rooms and levels approved for child care use:**

The living room, the kitchen, the dining room, the master bedroom, one additional guest bedroom, and the child care room are approved as child use space.

### **Areas not approved:**

All areas of the home are approved as child use space except for the blue guest bedroom (located to the left in the hallway).

### **Ages of children served:**

Ms. Blaskowski serves children ages birth to 12 years.

### **Equipment:**

There is a sufficient supply of developmentally appropriate equipment for the requested capacity of six children.

### **Proposed days and hours of operation:**

The facility operates Monday through Friday from 06:00 AM to 06:00 PM.

### **Previous or concurrent licenses, including children's foster care:**

Ms. Blaskowski was previously registered for child care at 12714 Paradise Lake Road, Cheboygan (DF160343882) from 08/29/2013 through 10/30/2013. She has had no concurrent licenses.

### **Exiting information (including second floor and basement):**

There are three exits in the child care room. One exit provides egress to the driveway, the second exit leads to the back yard, and the third exit leads into the kitchen. There is also an exit located in the living room which provides egress to


the front yard.

**Outdoor play area description:**

The outdoor play area is located in the fully fenced backyard. The children have access to various outdoor equipment.
