Dear Ms. Nelson:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 07/20/2021. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

When I arrived for the interim inspection, Ms. Nelson was providing care to five children; 1 related and four unrelated children. Children were finishing lunch, which was hot dogs, hot dog buns, French fries, peaches, and milk.

Ms. Nelson has a sufficient amount of developmentally appropriate equipment accessible for children to use. The equipment is well organized and inviting. Ms. Nelson converses with the children using a relaxed, soft voice. She is nurturing and makes eye contact with the children.

During the onsite inspection, I reviewed diapering procedures, infant safe sleep, fire safety, and daily activity programming. Ms. Nelson does not use one particular curriculum; however, she does provide a play-based experience for children that includes activities such as games, puzzles, art which includes letters, shapes, literacy, fine and large motor skills.

As I exited the home, Ms. Nelson and the children in care went outside to play. Children had opportunities to play with bubbles, chalk, bicycles, a small slide, a house, lawn mower, gas station, and glider. Ms. Nelson interacts with children in care in a positive manner; engaging in their play.

As a result of the inspection, I did not find any rule or law violations.


